Double glazed window to front, double radiator, television point, coving to ceiling.

KITCHEN/ DINING ROOM 12'2 (3.71) x 8'9 (2.67)

Double glazed window to side, single radiator, range of wall, floor and drawer units with co-ordinating roll edge work surfaces, co-ordinating sink unit and drainer with mixer tap, tile splash backs, built in electric fan assisted oven, gas hob with extractor fan above, integrated fridge, integrated freezer, plumbed for washing machine, vinyl flooring, double glazed door to side.

Double glazed window to rear, single radiator, fitted wardrobes and drawers.


