ENTRANCE HALLWAY

UPVC entrance door, stairs to first floor landing, radiator, storage cupboard.



LOUNGE/DINING ROOM 17'3 (5.26) x 13'10 (4.22)

Double glazed patio doors to rear, double radiator, fire surround with inset and hearth, gas fire, television point, coving to ceiling.

KITCHEN/DINING ROOM 8'6 (2.59) x 11'1 (3.38)

Double glazed window to front, feature radiator, range of wall, floor and drawer units with co ordinating roll edge work surfaces, co ordinating sink unit and drainer with mixer tap, tiled splash backs, built in electric fan assisted double oven, gas hob with extractor fan above, integrated fridge, freezer, plumbed for washing machine/dishwasher, tiling to floor.
